- 1:47 am (Approximately)– Yells at group get away from truck. Group starts coming towards him
- 1:48:00 am (Approximately)– Shot is heard on surveillance videotape
- 1:48:08 am (Approximately)– 2<sup>nd</sup> shot is heard, loud yell of male voice
- 1:55 am – 911 call is placed by client

## Testimony of Brandon Jenkins.

**(10:45am)- Daniel R. Spurling-** Was attacked by Casey King and Scott Earp outside Fireside 10/2/11 On his wedding night.

**Talina Spurling (wife of Daniel Spurling)-** Can relate what Daniel and Christina Martinez testify too. Was not drinking on night of incident and has total recall of events

**Christina D. Martinez-** Scott Earp grabbed her cell phone as trying to call 911 during fight-also was “poked” repeatedly in the chest by Scott and threatened (*I’ll break your fucking neck*). Was present on Incident outside Fireside 10/2/11. Sister of Daniel Spurling.

**(11:15am)- Jason Collins- Owner Friday Night Lights- To testify about altercation with Doug Earp on 11/20/11.**

**(11:30am)- Dustin Elliott-** Constant threats from Scott and Doug Earp starting back from 9/11/06 threatened as a witness to testify against them in 2007 for their 06’ burglary spree.

repeatedly requiring a 911 call and ambulance to take him to hospital. Still has scar above right eye from the night.

**(1:30pm)- Joshua N. Payne-** On 7/24/11 was leaving Fireside at closing allegedly “bumped” into Doug Earp outside where Doug demanded apology. Was followed down street by Scott Earp and Chris Arteberry where Scott was asking him to apologize to his brother. As crossing street Scott Earp grabbed Josh by the shirt with both hands to hold him until Doug and others in group could get down the street to attack him. Fight ensued. Police broke up. No charges filed.

**(2:00pm)- Ofc. Holly Hamilton #167, Olney PD-** incident R11-3665 on 7/17/11-arresting a minor for illegal consumption. Scott Earp began yelling at her that she was not going to arrest anyone and started sneaking up behind her. Ofc. Hamilton had to threaten to use her pepper spray to keep him back. **Was in fear for her safety.**



## Suspended Providers

Below is a list of child care providers recently suspended from the Wisconsin Shares program by the Department of Children and Families (DCF), because DCF reasonably suspects program violations, as allowed by new [Wisconsin law 49.155 \(7\) \(b\) 4 or 49.155\(7m\)](#).

These cases continue to be investigated and where applicable, overpayment collections pursued. The content below will be updated as additional information is gathered through the ongoing investigations. If the investigation reveals information that removes DCF's reasonable suspicion of program violations, child care providers will be removed from this list and their suspension from Wisconsin Shares will be lifted.

The providers here are suspended from the Wisconsin Shares program and therefore will not be receiving Shares payments, however it does not mean their licenses to provide care have necessarily been revoked. The investigations evaluate providers case-by-case and some providers may have revoked licenses or certifications or have chosen to voluntarily close.

All suspended providers have the right to appeal their suspensions to the Division of Hearings and Appeals within 30 days of the effective date of the suspension.



Past-due support constitutes a lien against a delinquent payer's real and titled personal property. The lien is effective as soon as it has been recorded on the **Child Support Lien Docket**. 

## Access to the Public Records of the Wisconsin Circuit Courts

This website (WCCA) provides access to certain public records of the Wisconsin circuit courts. The information displayed is an exact copy of the case information entered into the circuit court case management system by court staff in the counties where the case files are located. The court record summaries viewed here are all public records under Wisconsin open records law.

The data available on the WCCA website is limited in the following ways:

1. Case information is uploaded to the WCCA website hourly unless periodic maintenance is being performed or the site is experiencing technical problems. Petitioners, (persons seeking a restraining order) can register for automated notification of when a temporary restraining order (TRO) has been served or firearms have been surrendered. They can seek this information or register via VPO (VINE Protective Order) by calling toll-free at 1-855-948-7648 or on this website by clicking on the PROTECTIVE ORDER icon at the left of the screen.

You can search for your restraining order using the 12 digit court case number and the respondent's full name. Make sure you are spelling the name the same way it is spelled in Wisconsin Circuit Court Access (formerly CCAP) at: [www.wcca.wicourts.gov](http://www.wcca.wicourts.gov) You will then be able to register to receive notification. Please note that notification is only generated when TROs are served or firearms are collected by law enforcement and not private process servers or third parties.





### ACCESS TO GREEN BAY POLICE DEPARTMENT TRAFFIC ACCIDENT REPORTS

At the direction of the Office of the City Attorney, the Green Bay Police Department has temporarily removed all traffic accident reports from our website, pending the outcome of a decision issued by the Seventh Circuit Court of Appeals in *Senne v. Vill. of Palatine*, 695 F.3d 597, (7th Cir. 2012 *en banc*, cert. pet. filed 11/5/2012). The *Senne* decision held that under the provisions of the Driver's Privacy Protection Act (DPPA) personal identifying information derived from the Department of Motor Vehicles (DMV), including an individual's date of birth, driver's license number, social security number, home address, home telephone number, photograph, and medical or disability information is prohibited from disclosure to the public unless one of 14 DPPA exceptions apply. The DPPA preempts any conflicting state law that regulates the dissemination of motor vehicle record information. *Collier v. Dickinson*, 477 F.3d 1306, 1312, n. 3 (11th Cir. 2007).

The exceptions to the prohibition to disclosure under the DPPA are found at 18 U.S.C. § 2721(b). The DPPA does allow release of records, with the exclusion of personal and highly restricted personal information, derived from the DMV records. All non-personal information contained within records can be released to a requesting third party. For example, personal information does not include factual information as to where, when or how an accident occurred.

Accordingly, in compliance with the Seventh Circuit Court of Appeals decision and advice from the City Attorney's Office, the Green Bay Police Department, like many other police departments across the state, can no longer make available accident reports that include personal information prohibited from disclosure by the DPPA unless an exception applies.


